

SECTORIAL DISTRIBUTION OF ORGANISATION VISITED FOR PLACEMENTS IN 2021-22





CODE OF CONDUCT

We at Prestige value self discipline and do not believe in policing. We repose a lot of trust and faith in students. A detailed code of conduct which needs to be adhered by every students gives the students advance notice to abstain from misconducts.

General code of Conduct

- 1. Every student shall fulfill at least 75% attendance in the classrooms, failing which he/she will be debarred from appearing in examinations/internal assessments and participating, in activities organized/sponsored by the institute.
- 2. The Institute has declared to impose dress code, the students are advised to take the sample of uniform from the Institute's Office. However, students are allowed to wear formal dress on Wednesday & Saturday.
- 3. Using cellular phones inside the premises is not permitted. Violation of this rule will attract strict disciplinary actions. If a student continues to use the cellular phone even after a warning, his/her cellular phone will be seized.
- 4. The consumption of tobacco products such as Cigarettes, Bidis, Pan Masalas, Gutkhas etc. is strictly prohibited inside the premises and will attract strict disciplinary actions including heavy fines.
- 5. The misuse/mis-handling of Institute's resources such as library books, computer lab, equipments and furniture etc. may attract heavy fine and may lead to T.C & Rustication.

MAINTENANCE OF DISCIPLINE

Every student admitted in the Institute shall exhibit good behavior at all times, show diligence in studies, maintain decorum and dignity, take proper interest in co-curricular and extra curricular activities and observe all rules to maintain discipline in the Institute.

Any students found guilty of breach of discipline shall be punishable in accordance with rule 13 of ordinance 7 of Madhya Pradesh Vishwa Vidyalaya Adhiniyam, 1973, which is reproduced below:

- When a student has been found guilty of breach of discipline with in or outside the university or an Institution or persistent idleness or has been guilty of misconduct, the head of institution at which such student is studying may punish according to the nature and gravity of the offence.
 - A. Suspend such a student from attending classes for not more than a week at a time.or
 - B. Expel such a student from appearing in the next ensuing examination, or
 - C. Disqualify such a student from appearing in the next ensuing examination, or
 - D. Rusticate such a student.

- Before inflicting any punishment as a foresaid the head of the institution shall give the student concerned an opportunity of personal hearing and record the reasons of inflicting the punishment.
- The head of the Institution concerned shall have power to suspend (for such time as may be necessary) a student temporarily from the Institution pending enquiry into his conduct in connection with an alleged offence.
- 4. The period during which a student remains suspended for completion of an enquiry, shall be reckoned in the calculation of his attendance for appearing at an examination provided he/she is found innocent.
- 5. A student who has been rusticated shall not be admitted to another Institution with in the jurisdiction of the University. Ordinarily, the period of rustication shall not exceed two years. Other Universities shall be informed of the fact of rustication.
- 6. The rustication of a student from an Institution shall entail the removal of his name from the register of student.

Expulsion

The director of the Institution reserves the right to remove from the rolls, the name of any student or punish otherwise for.

- 1. Failure to pay college or hostel fees in the time.
- 2. Failure to perform according to prescribed standards.
- 3. Indulging in any activity derogatory to the Institution.
- 4. Participating in any political/unsocial demonstration.
- 5. Misconduct/Misbehavior inside or outside the premises.
- 6. Violence against any one.
- 7. Being involved or having been involved in the past in a criminal case or moral turpitude.
- 8. Sexual misconduct inside or outside the premises.

- Student found inside the premises after consumption of liquor and drugs or found in possession of liquor & drugs inside the premises.
- 10. Willful damage to Institute property.
- 11. Stealing.
- 12. Indulging in malpractice in examinations/internal assessments.
- 13. Continue to indulge in misconducts even after two warnings.
- 14. Indulging in ragging.
- 15. Continuous absence from classrooms without information.

Bus Rule

- Fee paid for transportation (Bus) purpose will not be refunded in any case. However a prior intimation before 1 month of the starting of next semester fee may be refunded.
- Any problem related to bus must be reported to A.O. on Mob No. 9131923011, 98277-57499, 0751-4097000
- 3. Bus stoppage will not be altered or changed.
- 4. Bus services may be terminated for the day due to unavoidable circumstance & will be informed in advance, hence local convenience or other mode must be used.
- 5. All Student must be present at the Bus Stop on the time given, Bus may be late at stoppage due to traffic jam or any other reason, hence you must ask to the students boarding the bus at previous stoppage and no phone must be made to drivers.
- Bus leaving time from the institute for morning shift is 2 PM & for the evening shift is 5:45 PM. So, all the students must board the bus on time.
- Departure time from the institute may be changed due to any reason such as Extra Class, Seminar or some other Events & Activities

Hostel Rule

- 1. One month notice must be given before leaving the hostel.
- 2. Student joining before 15th day of month have to pay full month fee & joining after 16th day of month will pay 1/2 month's fee.

RUSTICATION

Any student will be liable to immediate rustication by the Director, if in his opinion the student behaves in a manner subversive of discipline or commits grave misconduct.

RAGGING PROHIBITION ORDINANCE

- Ragging in any form is strictly prohibited with in the premises of the Institute.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this ordinance.
- Ragging for the purposes of the Ordinance, ordinarily means any act, conduct or practice by which power or status of senior students is brought to bear on students freshly enrolled or students who are in anyway considered junior by other students and includes the acts or practices which
- a. Involve physical assault or threat, or use of physical force;
- b. Violate the status, dignity and honor of women students;
- Violate the status, dignity and honor of students belonging to the scheduled castes or tribes;
- $d. \quad \text{Expose students to ridicule and contempt to affect their self esteem}.$
- Entail verbal abuse and aggression, incident gestures and obscene behavior.
- The director of the Institute shall take immediate action on getting any information about the occurrence of the ragging.

- 5. The Proctor may also suo motu enquire into any incident of ragging and make a report to the Director of the identity of those who have engaged themselves in ragging and the nature of the incident.
- The Proctor may also submit an initial report to the Director establishing the identity of the perpetrators of ragging and nature of the ragging incident.
- If the Director of the Institute is satisfied that for some reasons, to be recorded in writing, it is not reasonably practical or expedient to hold an enquiry, he may direct the Proctor accordingly.
- 8. On the receipt of the report under clause (5) or (6) or a determination by the Director disclosing the occurrence of ragging incidents in Clause 3(a), (b) and (c) the Director shall directly order rustication of a student or students for a specific number of years, or any other punishment that he deems fit.
- The Director may in other cases of ragging including the incident in Clauses 3(d) and (e) directly order any punishment that he deems fit.
- In case students who have obtained degree offered by the Institute
 are found guilty under this Ordinance, an appropriate action will be
 taken by the Director for withdrawal of degree conferred by the
 University.
- 11. For the purpose of this Ordinance, abetment to ragging will also amount to ragging.

Note: Decision of the Director for interpretation of the Ordinance will be final.


