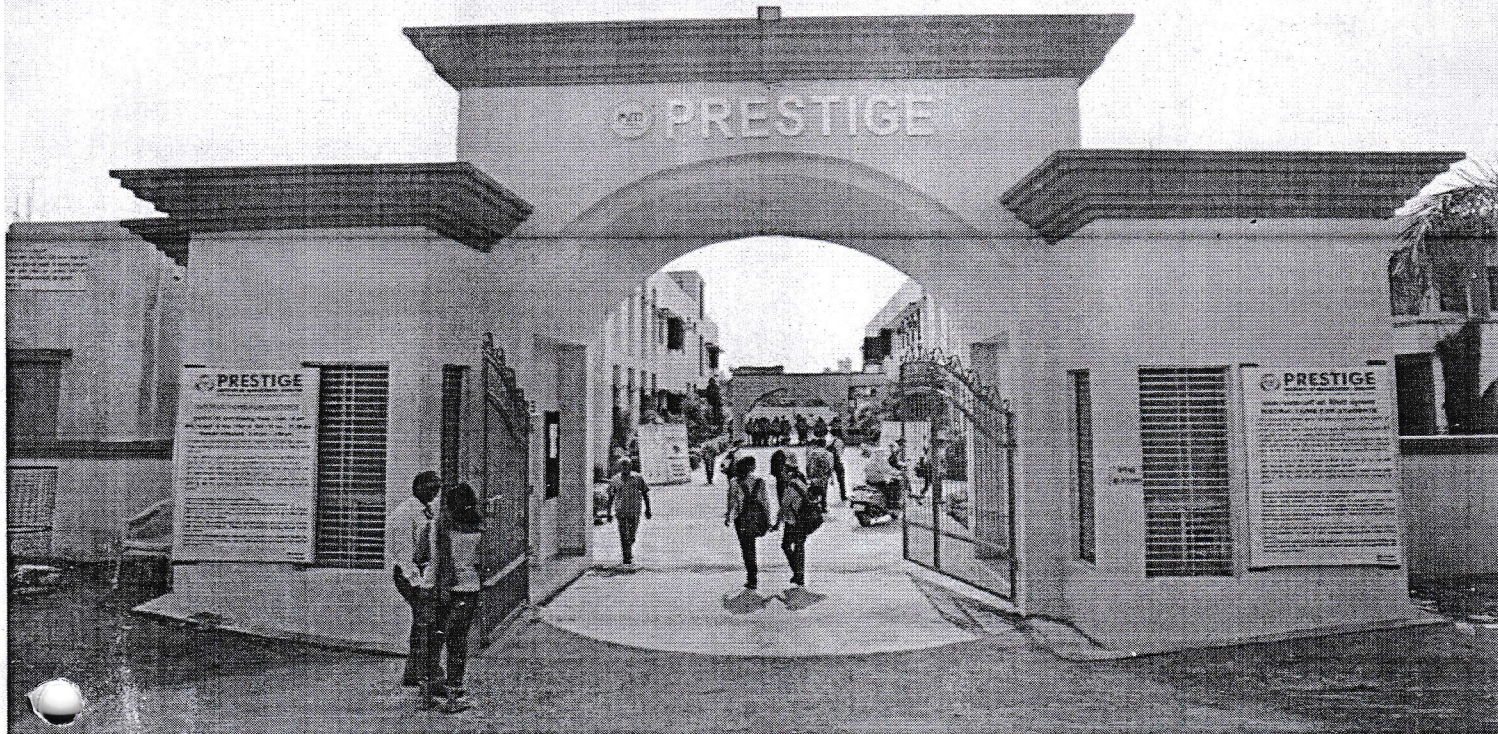

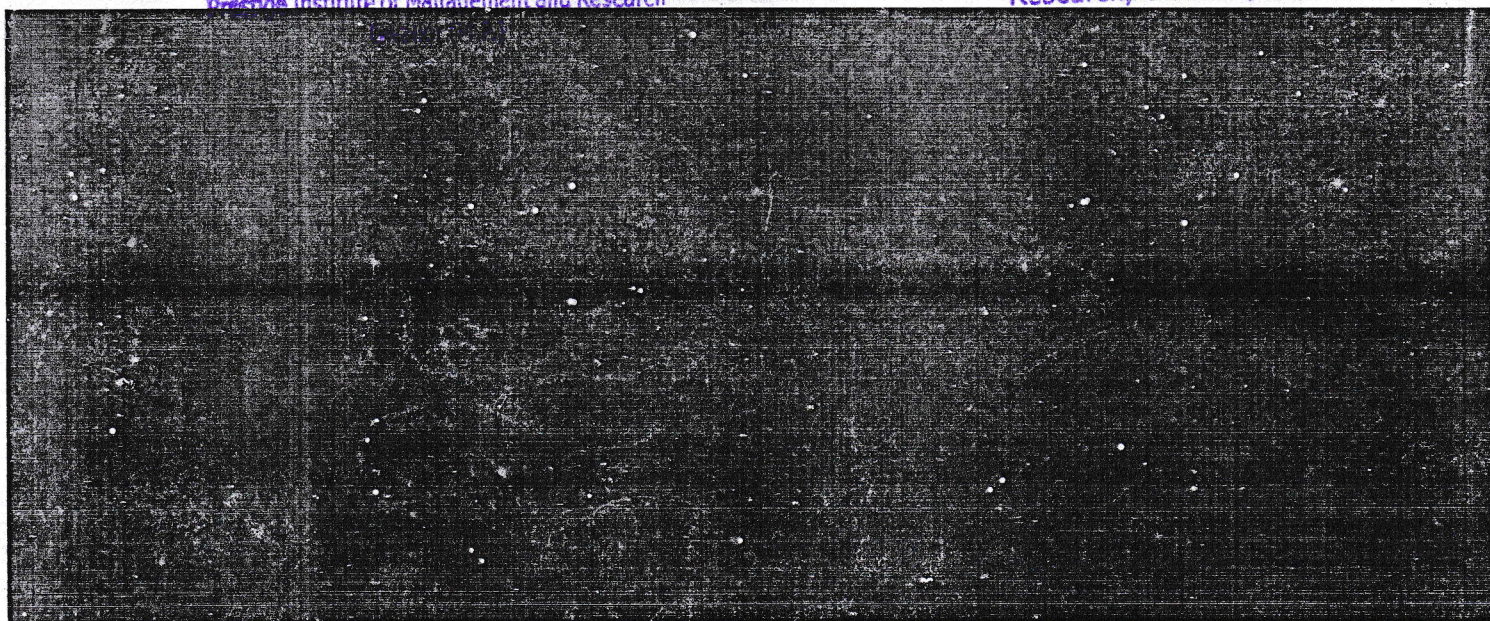

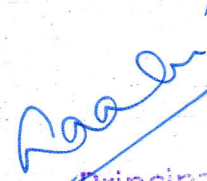
1. Introduction
